In September 2019, the laws of the Republic of Uzbekistan "On guarantees of equal rights and opportunities for women and men" and "On protection of women and girls from oppression and violence" were adopted. The law "On guarantees of equal rights and opportunities for women and men" emphasizes the prohibition of direct and indirect discrimination of women based on gender. This law was drafted in accordance with the decision of the leaders of our country on March 7, 2019 "On measures to further strengthen the guarantees of women's labor rights and support business activity". The purpose of this law is to protect women from all forms of harassment and violence at home, at work, in educational institutions and in other places.

CONCLUSION

In conclusion, it is necessary to convey and promote the content and essence of the reforms implemented in our country regarding the support and development of the state policy for women and girls.
