Domestic violence concept Uzbekistan Law of the Republic of Uzbekistan No. O'RQ-978 dated 21.10.2024 based on crime recognized as Uzbekistan Republic Crime Article 126¹ was added to the Code. According to the issue, "To his wife (husband), ex to his wife (ex) to the husband,

2. Rehabilitation centers - it is displayed for victim's temporary asylum, psychological and legal help;
3. In the neighborhoods social services is being expanded – “neighborhood” “guard “, “women active “ like positions activity is running.
